The Town of Bargersville issues utility appurtenance permits ["right-of-way permits" or "ROW permits"] for work completed within Bargersville-controlled right-of-way per Bargersville Municipal Code §92.04. As such, applicants are required to supply an approved performance bond for the work performed, which is accepted by the Town Council during a regular meeting.

In an effort to close open permits and release bonds for completed work, the Department of Development (with the assistance of the Clerk-Treasurer Department) has compiled a list of performance bonds accepted between January 1, 2017, and December 31, 2023, for ROW permits only. Staff formally submit this bond list for consideration to release en masse.
