

**TOWN OF BARGERSVILLE
ORDINANCE NO. 2026-01**

AN ORDINANCE AMENDING ORDINANCE 2025-09, WHICH ESTABLISHED THE TOWN OF BARGERSVILLE ARTS AND CULTURE COMMISSION

WHEREAS, the Town Council of the Town of Bargersville, Indiana (“Town Council”), previously adopted Ordinance 2025-09 establishing the Bargersville Arts and Culture Commission; and

WHEREAS, Ordinance 2025-09 established the membership of the Arts and Culture Commission as no fewer than seven (7) members and no more than nine (9) members; and

WHEREAS, the Town Council finds that a smaller commission will promote greater efficiency, improved coordination, and more effective operation of the Arts and Culture Commission; and

WHEREAS, the Town Council desires to amend Ordinance 2025-09 solely to reduce the minimum and maximum number of members serving on the Arts and Culture Commission;

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF BARGERSVILLE, INDIANA, AS FOLLOWS:

SECTION 1. AMENDMENT TO COMMISSION MEMBERSHIP

- A. Section 2, “**Structure of the Commission – Appointments,**” of Ordinance 2025-09 is hereby amended and shall read as follows (new language emphasized):
- B. **Appointments:** The Commission shall be an advisory body with no fewer than five (5) and no more than seven (7) members. One (1) member of the Commission shall be appointed by the Bargersville Parks Board. Members shall be appointed by the Bargersville Town Council President and the Bargersville Town Council in a manner consistent with Ordinance 2025-09. Up to two (2) appointees may be members of the Town Council. All members should be conversant with the arts and/or experienced with community issues.

SECTION 2. NO OTHER CHANGES

Except as expressly amended by this Ordinance, all other provisions of Ordinance 2025-09 shall remain in full force and effect without modification.

SECTION 3. EFFECTIVE DATE

This Ordinance shall be in full force and effect upon its passage by the Town Council and approval as required by law.
