Until further notice, Plan Commission and Board of Zoning Appeals meetings shall be conducted pursuant to Governor Holcomb's Back on Track Order. A broadcast link will be provided for public observation on the Town's website and social media platforms on or before the day of the posted meeting.

In accordance with the Governor's phased reopening plan, the Town of Bargersville is taking extra precautions to protect public health and safety. Phase 5 Reopening Guidelines require that social distancing guidelines are followed. Bargersville Town Hall allows for the seating of 10 attendees in manner that allows for proper distancing.
